REDUCED TAX RATE APPLICATION

A reduced personal property tax rate is available to veterans who qualify under the provisions of Code of Virginia §58.1-3506 (A) (19), and Hampton City Code Chapter 37, Article III, Division 2, Subdivision B, Sec. 37-163.

Qualifications are as follows:

If you do not have the Department of Veterans Affairs (VA) summary of benefits letter, please contact the Roanoke Regional Office and request: *The Letter for Real Estate Tax*

- A Veteran who has either lost, or lost the use of, one (1) or both legs, or an arm or a hand, or who is blind or who is permanently and totally disabled as certified by the Department of Veterans Affairs.
- The disability is service-connected.

The veteran must show an approved identification card from the Department of Defense or the Department of Veterans Affairs and provide a copy of the summary of benefits letter from the Department of Veteran Affairs (VA) indicating the following **VA Benefits Information:**

- Service-connected disability: **Yes**
 - Are you considered to be totally and permanently disabled due to your service-connected disabilities: **Yes**
- OR**
- Service-connected disability: **Yes**
 - Are you service-connected for loss of or loss of use of a limb, or are you totally blind in or missing at least one eye: **Yes**

Each qualified veteran will receive a reduced tax rate of \$.000001 per hundred dollars of assessed value on **one (1) motor vehicle owned and regularly used by the veteran.**

Complete the application below, attach a copy of your summary of benefits letter from the Department of Veterans Affairs, present approved identification card (you may fax or mail a copy of the front & back of an approved ID card), read and check each block below and return the completed application to the Commissioner of the Revenue.
