

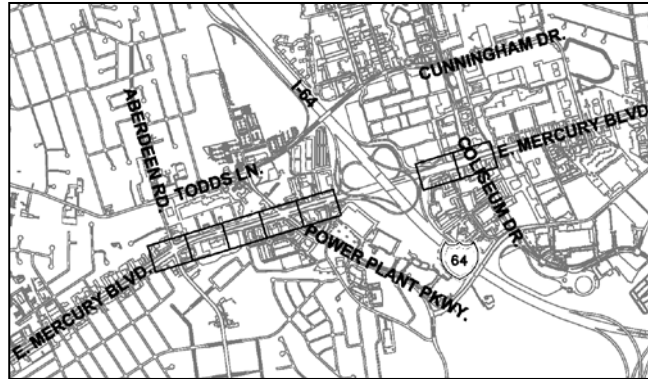

INTRODUCTION

The City of Hampton welcomes you to this Public Hearing for *Mercury Blvd. – Reconstruction of Sidewalks, Crosswalks and Lighting*. The purpose of this meeting is to provide the public or any person, acting on his/her own behalf or representing a group or governing body, an opportunity to offer comments or submit written material concerning the preliminary design of these roadway improvements. Representatives from the City of Hampton and the design consultants are present to discuss the project and answer your questions.

We welcome your written comments, which may be provided on the comment sheet inside this brochure. All written comments must be submitted for review and consideration within 10 days after the Public Hearing. Comments will be addressed and appropriate design changes will be incorporated into the final design.

PROJECT LOCATION

This project is located along Mercury Blvd, from Aberdeen Road to Coliseum Drive, (excluding the I64 interchange).

PROPOSED IMPROVEMENTS

The purpose of this project is to make streetscape improvements along Mercury Blvd, from Aberdeen Road to Coliseum Drive, (excluding the I64 interchange), including:

- New Sidewalks, Sidewalk Modifications
- Street lighting layout changes to replace existing median lights/poles.
- New and updated crosswalks and pedestrian signals

- Landscaping improvements along the existing sidewalks and center medians, if funding permits.

ESTIMATED PROJECT COST

The total cost for the project is estimated at \$750,000 including design and construction costs. The project will be funded using \$375,000 dollars of City of Hampton funding and \$375,000 of Virginia Department of Transportation Revenue Sharing funds.

PROJECT SCHEDULE

The anticipated schedule at this point in the project development is as follows:

Design: Completion in July, 2014

Right-of-way Acquisition: Not Applicable

Utility Relocation: Not Applicable

Construction: Fall 2014 – Spring 2015
